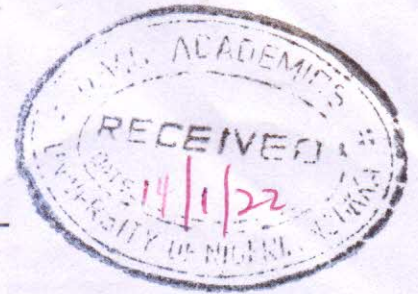

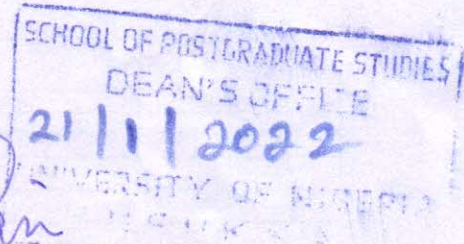

**REVIEW OF FEES OF THE CENTRAL BANK OF NIGERIA  
COLLABORATIVE POSTGRADUATE PROGRAMME (CBN-CPP)**

Please recall my letters of 25 February 2021, 16 September 2021, and 18 October 2021 in which I, respectively, informed you of the decision of the Incorporated Trustees of the CBN-CPP Board of Trustees' (BoT) on fees (tuition and accommodation) for the CBN-CPP, the bank account into which the fess due to CBN Centre for Economics and Finance would be paid, and sharing of the tuition fees.

I hereby wish to convey to you the BoT's decision to review the fees downward to **₦600,000.00** (Six Hundred Thousand Naira Only) per programme for the Master of Science degree programme in Economics, Accounting, and Banking and Finance, and **₦1,000,000.00** (One Million Naira only) per programme for the Master of Business Administration. In this regard, new students for Master of Science Programme would pay **₦400,000.00** (Four Hundred Thousand Naira) while returning students would pay **₦200,000.00** (Two Hundred Thousand naira). New and returning students for the Master of Business Administration would pay **₦500,000.00** (Five Hundred Thousand Naira) and **₦400,000.00** (Four Hundred Thousand Naira), respectively. Consequently, the share of the tuition fess going to the university is adjusted to **35.0%** for both new and returning students for Master of Science and Master of Business Administration programmes. Please see attached details. Accommodation fee is also reduced to **₦120,000.00** for One-person room and **₦80,000.00** for Two-person room per session.

It will be most appreciated if you could approve the new fee schedule and circulate same to the relevant offices for implementation.

Please accept, Mr. Vice-Chancellor, the continued assurances of my esteemed regards.
